Basic Divorce or Parenting Mediation: \$680

Includes:

Complex Divorce with Kids/ Property Division: \$1500

Includes:

- Initial intake meeting to gather details of the case.
- 3-6 virtual mediation sessions (120 mins/session).

- Maintenance Agreement

RETAINER FOR FAMILY MEDIATION:

For individual clients needing ongoing mediation for long-term family conflicts (e.g., co-parenting, child custody).

Family Law Retainer:

- \$1500/month for mediation or follow-up consultations as part of an agreement.
- 10 hours per month for ongoing family cases.

Business Partnership Mediation:

**Consists of x7 90 mins sessions

Includes:

- Initial discovery call/assessment (90 mins) for detailed exploration of conflict.
- Coordination of time zones, special communication software or platforms for international clients.
- Package of up to 7 sessions of mediation (approx. 60-90 minutes each).
- Optional follow-up meeting if needed within the first month post-session.
- Drafting of a formal settlement agreement to sign after the mediation process is concluded.
- Interem agreement option available while the settlement is being drafted and approved.





CORPORATE MEDIATION RETAINER PACKAGE

Retainer for Medium to Large Businesses:

- Monthly \$3500 for up to 10 hours/month.
- Hourly rates can apply once hours exceed the retainer limit.

Service:

Mediator available for ongoing consultations, conflict resolution, and business partnership disagreements.

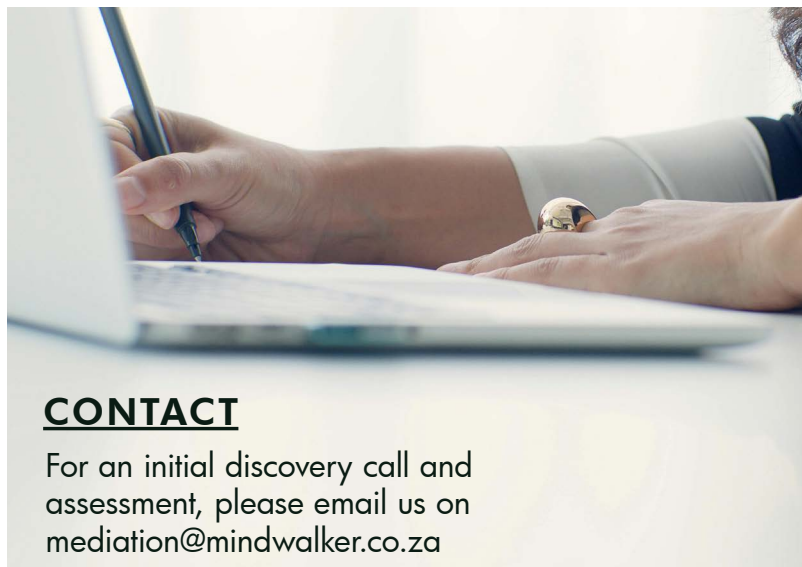
